A RESOLUTION AMENDING THE FISCAL YEAR 2019 BUDGET TO ACCEPT AND APPROPRIATE FUNDING FOR THE CITY OF OCALA'S COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM IN THE AMOUNT OF \$465,407

WHEREAS, the 2018-2019 Community Development Block Grant (CDBG) agreement was received on December 26, 2018 approving the Fiscal Year 2018 CDBG Action Plan and awarding funding for this fiscal year.

WHEREAS, the City was appropriated funding for FY 2018-19 from the U.S. Department of Housing and Urban Development to improve neighborhoods, provide decent housing and create new economic opportunities, with special focus on serving low-and moderate-income persons.

WHEREAS, The City was appropriated funds for FY 2018-19 in the amount of \$465,407 from HUD for the CDBG program.

NOW THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session that the FY2019 budget be amended as outlined below to appropriate \$465,407 to carry out activities as outlined in the City's CDBG Consolidated Plan.
