A RESOLUTION AMENDING THE FISCAL YEAR 2019 BUDGET TO APPROPRIATE FUNDING FOR THE PURCHASE OF TWO NEW POLICE CANINES IN THE AMOUNT OF \$11,000

WHEREAS, the Police Trust and Agency Fund was created to deposit revenues received as a result of federal criminal, administrative, civil forfeiture proceedings or community donations; and

WHEREAS, these funds may be used by the seizing agency, the Police Department, as necessary components not funded through the General Fund budget; and

WHEREAS, the department will enhance public and police safety with the utilization of \$11,000 of these funds to purchase two new police canines; and

WHEREAS, the Police Department has accumulated approximately \$800,000 in the account.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session, that the FY2019 Police Department budget be amended as outlined below to appropriate \$11,000 for the purchase of said canines.
