#### A RESOLUTION TO ADOPT A FINAL

#### BUDGET FOR THE CITY OF OCALA FOR FISCAL

### YEAR 2019-2020 IN THE AMOUNT OF \$820,297,193

WHEREAS, the City Council reviewed the proposed budget during a public workshop on August 13, 2019; and

WHEREAS, in accordance to Florida Statutes, Section 200.065, the Property Appraiser's Office mailed proposed tax bills on August 15, 2019 and a public hearing was scheduled for September 3, 2019; and

WHEREAS, the first public hearing was rescheduled for September 17, 2019 due to the anticipated impacts of Hurricane Dorian and was publicly noticed in the Ocala Star Banner on Friday, September 13, 2019 in compliance with the Department of Revenue Office of the Executive Director Emergency Order No. 19-001; and

WHEREAS, the required notice of tax increase and budget advertisements were published on September 20, 2019 and a public hearing to adopt the final millage rate and final budget was held on September 24, 2019; and

WHEREAS, this resolution includes the budgets for the Redevelopment Subarea Funds that were adopted by the Community Redevelopment Agency Advisory Board and the Downtown Development Fund previously adopted by City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled that the annual budget of \$820,297,193 for the City of Ocala for the period beginning October 1, 2019 through September 30, 2020, is hereby adopted as follows:
