# **BUDGET RESOLUTION 2022-102**

A RESOLUTION AMENDING THE FISCAL YEAR 2020-2021 BUDGET TO APPROPRIATE SUPPLEMENTAL FUNDS FROM THE FLORIDA DEPARTMENT OF TRANSPORTATION IN THE AMOUNT OF \$17,720

**WHEREAS**, the FDOT has appropriated supplemental funds through the attached SPTGA, in the amount of \$17,720; and

WHEREAS, under this SPTGA the City's matching obligation is \$4,430 and is available in the Airport fund.

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session that the Fiscal Year 2020-2021 budget be amended to appropriate funding as outlined below:

### OCALA'S RELEVANT STRATEGIC GOALS: Operational Excellence

#### **BACKGROUND:**

On May 18, 2021 City Council approved a grant from FDOT to fund the re-painting of Runway 18/36 at the Ocala Airport.

In working with the Engineer for the project, the scope was amended to include black outline paint. The contractor is also charging a premium for night time work.

In all, those items increase the total cost of the project by \$22,150, for a total project cost of \$211,150.

#### FINDINGS AND CONCLUSIONS:

- -Repainting of airfield markings is a periodic maintenance item at the Ocala International Airport. The City is utilizing the FDOT Airport Runway and Taxiway Airfield Marking Contract # BEA97 awarded to Florida Airfield Maintenance, JV. All quantity prices are established against the statewide bid.
- -The Airport Advisory Board reviewed the project at its June 2020 meeting and had no objections moving forward.
- -Work will be conducted at night in the fall 2021.
