A RESOLUTION AMENDING THE FISCAL YEAR 2021-2022 BUDGET TO APPROPRIATE FUNDING FOR OCALA POLICE DEPARTMENT SALARY ADJUSTMENTS TOTALING \$2,137,018

WHEREAS, the City of Ocala Police Department (OPD) has experienced a double-digit turnover in sworn and nonsworn positions throughout the department; and

WHEREAS, a salary study was conducted comparing local governmental agencies; and

WHEREAS, it was determined for OPD to compete, retain, and recruit experience, the salary minimums needed to be adjusted and the proposed increases will allow the Ocala Police Department to stay competitive with surrounding governmental agencies; and

WHEREAS, funds in the amount \$2,137,018 from the General Fund Reserve for Contingencies account will be utilized for this increase and distributed among the various Police Department accounts.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session, that the Fiscal Year 2021-2022 budget be amended as outlined below to appropriate \$2,137,018 for the personnel increases.
