## **BUDGET RESOLUTION 2022-107**

## A RESOLUTION AMENDING THE FISCAL YEAR 2020-2021 BUDGET TO COVER EXPENDITURES INCURRED AS A RESULT OF COVID-19 BY APPROPRIATIONS TOTALING \$394,963

WHEREAS, on January 20, 2020, the Secretary of Health and Human Services declared a public health emergency under section 319 of the Public Health Service Act (42 U.S.C. 247d); and

WHEREAS, on March 11, 2020, the World Health Organization announced that the COVID-19 outbreak can be characterized as a pandemic; and

WHEREAS, on March 13, 2020, President Donald J. Trump proclaimed that the COVID-19 outbreak constitutes a national emergency beginning March 1, 2020; and

WHEREAS, the severity of COVID-19 caused considerable unbudgeted expenses for the City of Ocala; and

**WHEREAS**, on August 4, 2020, City Council approved a subaward and grant agreement related to COVID-19 expense reimbursements; and

WHEREAS, CARES act revenue and budget reserves will be used to support the unforeseen emergencies and expenditures incurred in fiscal year 2020-2021 that were a result of COVID-19.

NOW THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session, that the FY2021 budget be amended as outlined below:
