BUDGET RESOLUTION 2022-139

A RESOLUTION AMENDING THE FISCAL YEAR 2021-2022 BUDGET TO ACCEPT AND APPROPRIATE LOCAL MATCHING FUNDS IN THE AMOUNT OF \$552,000; \$16,836 FROM THE DISPOSITION OF SUNTRAN BUSES; AND \$145,000 FROM BUS FARES, BUS PASSES AND FUEL TAX REFUNDS TO SUPPORT THE OCALA/MARION COUNTY PUBLIC TRANSIT SYSTEM, SUNTRAN, FOR A TOTAL OF \$713,836

WHEREAS, in fiscal year 2021-2022 the City budgeted \$414,000 and Marion County budgeted \$138,000 to be used as the local matches to SunTran grants; and

WHEREAS, local matches are needed for existing Federal Transit Administration (FTA) grants FL-2020-019-00 and FL-2018-121-00 and the Florida Department of Transportation's Public Transportation Grant Agreement #433304-1-84-02; and

WHEREAS, the City received FTA approval to dispose of 11 old SunTran buses that had exceeded their useful life expectancy by mileage and age stating that the FTA no longer had any monetary interest in them; and

WHEREAS, the 11 old buses were sold at auction for \$16,836; and

WHEREAS, revenue generated from the sale of bus fares and passes as well as fuel tax refunds is anticipated to be \$145,000 for FY22.

NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session, that the FY 2022 budget be amended as outlined below to appropriate funding as follows:
