Quality Water to Every Tap

City of Ocala Water Resources is pleased to provide this year's Water Quality Report. We would like to keep you informed about the excellent water and services delivered over the past year. Our goal is, and always has been, to provide a safe and dependable supply of drinking water.

Our water is obtained from ground water from six source wells which draw from the Upper Floridan Aquifer. The water is softened and chlorinated for disinfecting purposes and fluoridated for dental health purposes. This report shows our water quality results and what they mean. Ocala's water treatment facilities have won numerous Department of Environmental Protection awards for excellence in operations, distribution and maintenance.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

In 2022, the Florida Department of Environmental Protection (FDEP) performed a Source Water Assessment on our system. The assessment was conducted to provide information about any potential sources of contamination in the vicinity of our wells. There are 39 unique potential sources of contamination identified for this system with low to moderate concern levels. Types of Contaminants

Contaminants that may be present in source water include:

- (A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations or wildlife.
- (B) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- (C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- (D) Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.
- (E) Radioactive contaminants, which can be naturallyoccurring or the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the Environmental Protection Agency (EPA) prescribes regulations, which limit the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Maximum Contaminant Levels (MCL) are set at very stringent levels. To understand the possible health effects described for many regulated contaminants, a person would have to drink two liters of water every day for a lifetime at the MCL to have a onein-a-million chance of having the described health effect.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Glossary

For clarity regarding terms and abbreviations in the accompanying tables, please see the following definitions:

Action Level (AL):

The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

Initial Distribution System Evaluation (IDSE):

An important part of the Stage 2 Disinfection By-Products Rule (DBPR). The IDSE is a one-time study conducted by water systems to identify distribution system locations with the highest concentrations of trihalomethanes (THMs) and haloacetic acids (HAAs). Water systems will use results from the IDSE, in conjunction with their Stage 1 DBPR compliance monitoring data, to select compliance monitoring locations for the Stage 2 DBPR.

Maximum Contaminant Level (MCL):

The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG):

The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL):

The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG):

The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Not Detected (ND):

Indicates that the substance was not found by laboratory analysis.

Parts per million (ppm) or Milligrams per liter (mg/L):

One part by weight of analyte to one million parts by weight of water sample.

Parts per billion (ppb) or Micrograms per liter (µg/L):

One part by weight of analyte to one billion parts by weight of water sample.

Parts per trillion (ppt) or nanograms per liter (ng/l):

One part by weight of analyte to one trillion parts by weight of the water sample.

Picocurie per Liter (pCi/L):

Measure of the radioactivity in water.

Treatment Technique (TT):

A required process intended to reduce the level of a contaminant in drinking water.



2022 Water Quality Test Results

The City of Ocala routinely monitors for contaminants in your drinking water according to federal and state laws, rules and regulations. Except where indicated otherwise, this report is based on the results for the period January 1, 2022 through December 31, 2022. The state allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, are more than one year old. Data obtained before January 1, 2022, and presented in this report are from the most recent testing done in accordance with the laws, rules and regulations.

For chlorine, the level detected is the highest running annual average (RAA), computed quarterly, of monthly averages of all samples collected. For HAA5 or TTHM, the level detected is the highest result of samples taken on May 10, 2022 or August 9, 2022. Range of Results is the range of individual samples collected during the past year.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead contamination is primarily caused by materials associated with service lines and home plumbing. Ocala Water Resources cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may have it tested. 2022 Water Quality Test Results Cont'd.

Our water system has sampled for a series of unregulated contaminants. Unregulated contaminants are those that don't yet have a drinking water standard set by the EPA. The purpose of monitoring for these contaminants is to help EPA decide whether the contaminants should have a standard. We voluntarily monitor for Per and Polyfluoroalkyl substances (PFAS) annually and have included the results above. The EPA set an Interim Health Advisory (HA) of 0.02 ng/L for PFOS and 0.004 ng/L for PFOA. A final HA was set for PFBS at 2,000 ng/L. Results in the Level Detected column are the highest detected level at the point of entry.
