

## Art in City Spaces Exhibit Application

The City of Ocala's Art in City Spaces program provides the opportunity for artists and art organizations to exhibit their artwork in a public City space. Interested parties must first submit an application, and, upon approval, an exhibit agreement is executed, and an exhibition time is scheduled.

The City of Ocala recommends that artist(s) plan on delivering a minimum of 15-20 works for a show in any of the City spaces. Spaces are available on a first come, first serve basis to approved applicants. The City of Ocala reserves the right to adjust the exhibit display in an effort to showcase the artist's work in the best possible way. The City of Ocala will have the sole discretion in selecting the works to install.

Exhibits are typically 6 months in length. Spaces available for exhibits include:

- City Hall, 1st and 2nd Floor Lobbies, 110 SE Watula Ave., Ocala, FL 34471.
- **Recreation and Parks Administration Building** (Conference Room) and Eighth Avenue Adult Activity Center, 828 NE Eighth Ave. Ocala, FL 34470.
- Mary Sue Rich Community Center at Reed Place, 1821 NW 21st Ave, Ocala, FL 34475.
- Ocala International Airport, 1770 SW 60th Ave Suite 600, Ocala, FL 34474.
- Ocala City Clerk's Office, 110 SE Watula Ave., Ocala, FL 34471.

The City of Ocala seeks interesting, thought provoking exhibits that are appropriate for a public City space where work will be viewed by citizens and guests of all ages. Only complete applications are reviewed. Viewer engagement, artist intent and originality of ideas, and use of media and technique are all considered when an application is being considered for approval.

## City of Ocala's Responsibilities:

- The City of Ocala will assist in installing and promoting the exhibit.
- Exhibit spaces include a professional hanging system for 2-D artwork (www.gallerysystem.com) with the potential to exhibit semi-3-D and 3-D work depending on the scale and materials within certain spaces as determined by the City of Ocala.
- Artwork is insured for the loan period stated on the exhibit agreement.
- The City of Ocala will receive a 30% commission on sales. In the event of a sale, the work must remain on exhibition until the end of the show.
- The City of Ocala will provide informational signs and labels as needed to go along with the exhibit.

## Artist and/or Art Organization Responsibilities:

- Artists are responsible for creating and delivering the work to the gallery space at the agreed upon time. Artists will also be responsible for the removal of the artwork.
- Artists are expected to assist in the hanging of their show.
- All works should be wired for hanging or ready to display on a pedestal. All 2-D works must be
  properly framed, using "D" ring hangers with wire as appropriate. Saw tooth hangers are NOT
  acceptable.
- Artists will cooperate in publicizing the exhibition by providing high resolution digital images and by providing biographical information, in a timely fashion (usually within <u>8 weeks before the show</u>). An artist profile photo of professional grade and manner is also required for marketing purposes.
- All work may be offered for sale during the show but may not be removed until the exhibit's closing.
- Images of work must be submitted with the application and should accurately represent works being submitted for exhibit. **Please send images by email or CD/DVD in jpg format, 1 MB max/image.**
