A RESOLUTION AMENDING THE FISCAL YEAR 2023-24 BUDGET TO ACCEPT AND APPROPRIATE LOCAL MATCHING FUNDS IN THE AMOUNT OF \$188,903 FROM MARION COUNTY AND \$566,707 FROM THE CITY OF OCALA TO SUPPORT THE OCALA/MARION COUNTY PUBLIC TRANSIT SYSTEM, SUNTRAN, FOR A TOTAL OF \$755,610

WHEREAS, in Fiscal Year 2023-24 the City of Ocala budgeted \$566,707 and Marion County budgeted \$188,903 to be used as the local matches to SunTran grants; and
