A RESOLUTION TO AMEND THE FISCAL YEAR 2019-2020 BUDGET TO ACCEPT AND APPROPRIATE FUNDS FROM THE FORT KING HERITAGE ASSOCIATION, INC. AND MARION COUNTY FOR PROPERTY ACQUISITION RELATED TO THE FORT KING NATIONAL HISTORIC LANDMARK IN THE AMOUNT OF \$200,000

WHEREAS, the Fort King National Historic Landmark is jointly owned by the City of Ocala and Marion County; and

WHEREAS, on October 7, 2014, the City of Ocala, Marion County and Fort King Heritage Association, Inc. (FKHA) entered into a three-party Memorandum of Understanding (MOU) for purposes of delineating roles related to fundraising, development and management of the Fort King National Historic Landmark ("Site"). Per this MOU, the City is the lead operating entity of the Site; and

WHEREAS, on May 5, 2015, an amendment to the 2014 MOU was approved for purposes of incorporating new property acquisitions and long-term leases into the project boundary; and

WHEREAS, it is anticipated that the City, County and FKHA will acquire two additional contiguous properties "the Dobbs Parcel" by December 31, 2019; and

WHEREAS, the FKHA and the County have each agreed to contribute \$100,000 for a total of \$200,000 toward the purchase of the Dobbs Parcel; and

WHEREAS, the 2014 MOU has been further amended for purposes of incorporating the anticipated Dobbs Parcel into the Site as described in the MOU.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session, that the FY2020 budget be amended as follows to accept and appropriate \$200,000 in donations from the Fort King Heritage Association and Marion County for purposes of acquiring the Dobbs Parcel for incorporation into the Fort King National Historic Landmark.
